## DOT Seller reporting requirement

Beginning January 1, 2016, law went into effect requiring a person who sells a motor vehicle to another person, including transferring a junk vehicle by bill of sale, to submit notification to the department that a sale has occurred. **This law does not apply for transfer to or from dealers or other non-individuals, such as companies, charities and government agencies; this requirement is ONLY for sales from one individual to another individual.**

Within 30 days of a sale the seller needs to report to WisDOT the following: 1) Vehicle identification number (VIN) of the vehicle, 2) Identity of the individual buyer, 3) Sale price, and 4) Date of sale.

## Retiree payroll changes

With the WEC changeover to Fidelity handling the retiree pay, there were changes to the retiree payroll deductions. WEC will no longer deduct funds from retiree payroll for credit union deposits. We have mailed forms to those retirees with payroll and made arrangements for us to withdraw funds from checking/savings accounts at other financial institutions.

While the company paid retirees on June 30th and July 1st, our withdrawal will only occur for the payroll on July 1st and each month thereafter on the first business day of the month.
